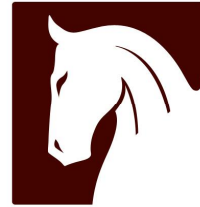

JENEWEIN GROUP made the right move

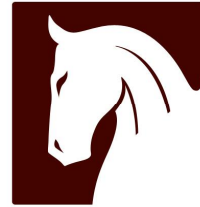
