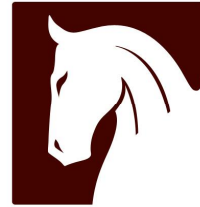

## JENEWEIN GROUP has retained ISO 9001:2000 certificate

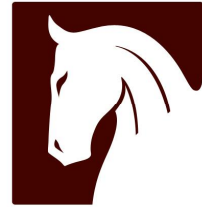
