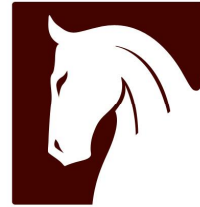

JENEWEIN GROUP has strengthened its team

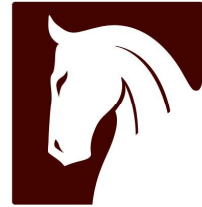
